# Dr Judith Puttkammer becomes head of the Mobility Competence Group at eco – Association of the Internet Industry e.V.

eco supporting member Mobility Data Space aims to promote resilience in the connected mobility ecosystem

**Munich, 16.12.2025.** On 1 January 2026, Dr Judith Puttkammer, Director of Business Development at Mobility Data Space, will become head of the Mobility Competence Group at eco – Association of the Internet Industry e.V.. Puttkammer will share the leadership role with Paula Böcken, Senior Public Policy Associate for Germany and Switzerland at UBER. The eco Mobility Competence Group supports the dialogue between innovators from the automotive, digital and mobility industries.

The Mobility Data Space (MDS), a data space for the exchange of mobility-related data funded by the Federal Ministry of Transport, is a supporting member of eco. Together with the association, the MDS aims to promote digitally driven concepts and solutions to make tomorrow's transport and traffic safer, more reliable, more efficient and more climate-friendly. To this end, the MDS offers a decentralised infrastructure that enables simple, secure and sovereign data exchange between companies and organisations. The eco Mobility Competence Group deals with a number of future topics in which data plays a central role – from dual use to data ecosystems and digital infrastructures as the basis for software-defined vehicles to autonomous driving.

As Director of Business Development at MDS, Puttkammer is committed to projects that aim to achieve the regular operation of automated vehicles. This requires, in particular, the simplification and harmonisation of approval processes. 'The MDS is taking on this task,' she says. 'Thanks to its independent mediating role and its broad network of companies, authorities, federal states and research institutions, it is ideally placed to drive forward harmonisation and mediate neutrally between the various players.'

The MDS also supports projects that aim to bring autonomous vehicles onto our roads with a broad portfolio of services ranging from the definition and validation of operating conditions (ODD, Operational Design Domain) to the implementation of reporting requirements and secure data export. The data space MDS is also a partner in autonomous driving projects such as the Alliance 'Mobile Future Munich and Region' (MZM) and the ALIKE project.
