Marc Augusto and Moritz Stober join senior executive team

Mobility Data Space expands its Management Board

Munich, 08.04.2025. The Mobility Data Space (MDS) has expanded its Management Board. As of this April, Marc Augusto (31) and Moritz Stober (34) will be responsible for the organisation's operational management. Founding Managing Director Manfred Rauhmeier will remain responsible for the MDS's strategic direction and will use his wealth of experience to support the senior executive team. Augusto will take charge of Technology, Services and Governance, while Stober will head up the Market, Community and Marketing sides.

Funded by the Federal Ministry for Digital and Transport, the Mobility Data Space is a data space for mobility-related data. It provides an operational platform for sovereign data exchange and trading as well as an active community that promotes data-driven solutions for tomorrow's mobility. Both the Technology and the Community sides will benefit from the expanded Management Board.



Augusto will drive the ongoing scaling of the MDS platform and its interoperability with other data spaces at home and abroad. In his view, the MDS has great potential to open up access to the large amount of mobility-related and valid data for AI applications. As he explains, "In Germany alone, there is tremendous potential to use domain-specific data to develop innovative solutions and improve the efficiency of existing processes. We want to enable people to leverage this data and put it to good use".

Augusto has acquired ample experience of mobility issues in his career to date. After studying computer science, he worked on digitalisation and automation in container ports. Having also been a partner and programme manager at ZEKI (the Center for Tangible Artificial Intelligence and Digitalization), in his most recent post at the Technische Universität Berlin he contributed to advances in the field of autonomous driving.

In his new role as Managing Director, Stober, who was already Director of Business Development at the MDS, will now also focus on the Community side of the organisation. The MDS Community team engages in everything from the recruitment of new participants to providing process support for the development of new use cases. In addition, Stober plans to enhance the user experience by expanding the services delivered by the MDS and its partners. He is also involved in standardisation initiatives and is in contact with various other data spaces. "The huge potential of the data economy can't be unlocked solely by creating the necessary technology. We also need to get data providers and users excited about these new opportunities."



Before joining the MDS, Stober worked on data space development at acatech, the organisation from which the MDS originated. During his time at acatech, he was responsible for strategic mobility projects and supporting key mobility stakeholders. Prior to that, the economics graduate worked as a Senior Consultant at the accounting firm Ernst & Young, where his duties included organising digital transformation projects.
